Anyone found under the influence or in possession of alcohol or illegal drugs will be immediately removed from the activity and will be held responsible for all additional costs (fines and/or travel expenses) arising from this dismissal.

In consideration of being permitted to participate in recreation activities organized by Dorchester County and partners, registrant hereby **releases, waives and discharges** County, its officers, employees, members, partners, promoters, sponsors, and advertisers from all liability to the registrant, his/her spouse, legal representatives, heirs and assigns, for any and all loss or damage, and any claim or damages resulting there from, on account of injury to registrant's person or property, even injury resulting in death of the registrant, whether caused by the negligence of County, others released herein, or otherwise while the registrant is in any way participating in the events surrounding Dorchester County activities. Registrant agrees to **indemnify** the County, its officers, employees, members, promoters, sponsors, and advertisers from any loss, liability, damage or cost they may incur due to the presence of registrant in said activities. Registrant hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of County or otherwise participating in the recreation programs. Registrant expressly agrees that this **release, waiver, and indemnity** agreement is intended to be as broad and inclusive as permitted by the Laws of the State of South Carolina and that if any portion thereof is held invalid, it is agreed that the remaining portion shall continue in full legal force and effect.

The property known as Rosebrock Park (the "Park") contains and presents many natural and artificial dangers, including alligators and venomous snakes, which are capable of causing property damage, serious injury (including without limitation physical injury and general risk to health and well-being) or death. Despite the dangers and risks, I desire to enter the Park and participate in the program. I acknowledge and understand the risks associated with entering and otherwise being present in and about the Park, and understand that property damage, serious personal injury and/or death may occur as a result of the risks.

The undersigned represents that registrant is authorized to sign and enter into this letter of agreement. If participant is a minor the undersigned represents that you are the legal guardian of the registrant and authorized to enter into this letter of agreement on their behalf.
