ORDINANCE NUMBER 19-__

COUNTY OF DORCHESTER

**ORDERING A REFERENDUM PURSUANT TO THE COUNTY BOND ACT FOR THE
PURPOSE OF DETERMINING WHETHER DORCHESTER COUNTY, SOUTH CAROLINA
SHALL BE AUTHORIZED TO ISSUE NOT EXCEEDING \$38,000,000 GENERAL
OBLIGATION BONDS FOR THE PURPOSE OF
FUNDING PARKS AND RECREATIONAL FACILITIES**

WHEREAS, it is provided in Section 14 of Article X of the Constitution of South Carolina that the political subdivisions of the State shall have power to incur general obligation debt without limitation if the same be authorized by a majority vote of the qualified electors of the political subdivision voting in a referendum authorized by law; and

WHEREAS, statutory authorization for the holding of the election and the issuance of bonds is provided by Sections 4-15-10 to 4-15-180, inclusive, of the Code of Laws of South Carolina 1976, as amended (herein called the "County Bond Act"); and

WHEREAS, the County Council of Dorchester County, South Carolina (the "County Council"), the governing body of Dorchester County, South Carolina (the "County"), desires to fund the acquisition of land and the design and construction of parks and recreational facilities at various locations throughout the County, including the development of the Dorchester County Courthouse Park in St. George, the Ashley River Park, the Ashley River Park-Rosebrock Park-Swamp Fox Connector and the Pine Trace Natural Area in Summerville, and the development of hiking, biking and pedestrian trails and bridges, together with associated infrastructure, at various locations throughout the County (collectively, the "Recreation Projects"); and

WHEREAS, the County Council further desires to fund the Recreation Projects through the issuance of not exceeding \$38,000,000 of general obligation bonds of the County provided that such bonds are authorized by a majority vote of the qualified electors of the County voting in a referendum; and

WHEREAS, the County Council has now determined to order a referendum for the purpose of seeking voter approval to issue not exceeding \$38,000,000 of general obligation bonds of the County in order to fund the Recreation Projects.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL OF DORCHESTER COUNTY, SOUTH CAROLINA, IN MEETING DULY ASSEMBLED:

Section 1.

A referendum pursuant to the County Bond Act is hereby ordered to be held in Dorchester County, South Carolina at the election on Tuesday, November 5, 2019 (the "Referendum"), at which there shall be submitted to the qualified electors of the County the following question:

REFERENDUM QUESTION – DORCHESTER COUNTY PARKS AND RECREATION

AUTHORIZATION FOR ISSUANCE OF NOT TO EXCEED \$38,000,000
GENERAL OBLIGATION BONDS TO FUND PARKS AND RECREATIONAL
FACILITIES IN DORCHESTER COUNTY

Shall Dorchester County, South Carolina be authorized to issue general obligation bonds in an amount not to exceed \$38,000,000 for funding the acquisition of land and the design and construction of parks and recreational facilities at various locations throughout the County, including the development of the Dorchester County Courthouse Park in St. George, the Ashley River Park, the Ashley River Park-Rosebrock Park-Swamp Fox Connector and the Pine Trace Natural Area in Summerville, and the development of hiking, biking and pedestrian trails and bridges, together with associated infrastructure, at various locations throughout the County?

Section 2.

A certified copy of this Ordinance shall be delivered to the Dorchester County Board of Elections and Voter Registration which shall be requested to conduct the Referendum at the election held on November 5, 2019, and they shall be requested to direct the Managers of Election to conduct this Referendum and thereafter to certify the results of such Referendum to this County Council.

Section 3.

A Notice of Referendum, substantially in the form attached hereto as Exhibit A, shall be published in a newspaper published in the County and in compliance with the provisions of Sections 7-13-35 and 4-15-50 of the Code of Laws of South Carolina 1976, as amended (or any other applicable statutory provisions enacted subsequent to the date of enactment of this Ordinance) not less than 60 days prior to the Referendum and not later than two weeks after such first notice is published.

NOTICE OF REFERENDUM

**AUTHORIZATION FOR ISSUANCE OF NOT TO EXCEED \$38,000,000

FACILITIES IN DORCHESTER COUNTY**

NOTICE IS HEREBY GIVEN that a Referendum will be held in Dorchester County, South Carolina (the "County"), on November 5, 2019, for the purpose of submitting to all persons qualified to vote in the County, under the Constitution and laws of the State of South Carolina, the following question:

Shall Dorchester County, South Carolina be authorized to issue general obligation bonds in an amount not to exceed \$38,000,000 for funding the acquisition of land and the design and construction of parks and recreational facilities at various locations throughout the County, including the development of the Dorchester County Courthouse Park in St. George, the Ashley River Park, the Ashley River Park-Rosebrock Park-Swamp Fox Connector and the Pine Trace Natural Area in Summerville, and the development of hiking, biking and pedestrian trails and bridges, together with associated infrastructure, at various locations throughout the County?

If you are in favor of the question, place a check or cross mark in the square after the words "In favor of the question"; if you are opposed to the question, place a check or cross mark in the square after the words "Opposed to the question".

Every person offering to vote must be at least 18 years of age on the date of the Referendum, must reside in the County and must be duly registered on the books of registration for the County as an elector in the precinct in which he or she resides and offers to vote on or before the date on which said books of registration are closed for the Referendum, and must produce, upon presenting himself or herself to vote, a valid and current: (1) South Carolina driver's license, (2) other form of identification containing a photograph issued by the South Carolina Department of Motor Vehicles, (3) passport, (4) military identification containing a photograph issued by the federal government, or (5) South Carolina voter registration and containing a photograph of the voter. Persons who do not or cannot present valid and current identification as provided herein may cast a provisional ballot in accordance with Section 7-13-710 of the Code of Laws of South Carolina, 1976, as amended.

Any persons wishing to register to vote in this election, if registering by mail, must have such registration postmarked not later than October 7, 2019, and mailed to the Dorchester County Board of Elections and Voter Registration, 201 Johnston Street, St. George, South Carolina 29477, or, if registering to vote in person, must do so by no later than October 5, 2019. Any such registered elector who has moved his or her place of residence within the County after the date on which said books of registration are closed for the Referendum, but before the date of the Referendum, shall be entitled to vote in his or her previous precinct of residence in the Referendum; provided, however, in case any registered elector shall have moved from one precinct in the County to another precinct in the County within thirty days

prior to November 5, 2019, and shall have surrendered his registration certificate and has received a new certificate, such elector may vote in the precinct provided for by such new certificate. Persons who become of age during the 30 day period preceding the Referendum shall be entitled to register before the closing of the books if otherwise qualified.

Any person eligible to register to vote in the Referendum who has been discharged or separated from his service in the Armed Forces of the United States prior to November 5, 2019, and has returned home too late to register at the time when registration is required, is entitled to register for the purpose of voting in the Referendum after the discharge or separation from service, up to 5:00 p.m. on the day of the Referendum. This application for registration must be made at the office of the Dorchester County Board of Elections and Voter Registration, and if qualified, the person must be issued a registration notification stating the precinct in which he is entitled to vote and a certification to the managers of the precinct that he is entitled to vote and should be placed on the registration rolls of the precinct.

The polls shall be open from 7:00 a.m. until 7:00 p.m. at the polling places designated below and shall be open during these hours without intermission or adjournment. Appropriate vote recorders will be provided at the polling places for the casting of ballots on the aforesaid question. Managers of Election will be appointed by the Dorchester County Board of Elections and Voter Registration. The Managers of Election shall see that each person offering to vote takes the oath that he is qualified to vote at this election according to the Constitution of this State, and that he has not voted before in this election. The precincts within the County and locations of the several polling places for such Referendum are as follows, subject to final designation by the Dorchester County Board of Elections and Voter Registration:

Voters who are blind, who are otherwise physically handicapped, or who are unable to read or write are entitled to assistance in casting their ballot. This assistance may be given by anyone the voter chooses except his employer, an agent of his employer, or an officer or agent of his union. The Managers of Election must be notified if assistance is needed. Voters who are unable to enter their polling place due to physical handicap or age may vote in the vehicle in which they drove, or were driven to the polls. When notified, the Managers will help voters effectuate this curbside voting provision. Registered voters may be eligible to vote by absentee ballot. The Dorchester County Board of Elections and Voter Registration shall hold a hearing on ballots challenged in the election on Friday, November 8, 2019, at 10:00 a.m., at the office of the Dorchester County Board of Elections and Voter Registration, 235 Deming Way, Summerville, South Carolina. The process of examining the return-addressed envelopes containing absentee ballots will begin at 9:00 a.m. on November 5, 2019.
